## SPONSOR'S AFFIDAVIT OF SUPPORT

A sponsor may be a parent, family member, or another person who will provide financial support to the student. It is not necessary that a financial sponsor live in the U.S. If there is more than one sponsor, each sponsor must complete a separate form. One financial sponsor may provide complete or partial support for the student, but the student's total financial support must equal or exceed the total estimated costs noted on page 1. If a business account is being used then additional documentation is required to confirm who can authorize funds for this purpose; a letter from the company on letterhead, a business tax return showing the sponsor's name or a company check with the sponsor's name appearing on it.

**To the financial sponsor:** In addition to signing this document, you must provide a bank statement that includes your name, the name of your bank, the statement date, amount of the available funds and type of currency. The bank statement must be in English or include a certified English translation and clearly show the information required. Checking, savings or investment accounts including retirement will be accepted.

***Bank statements must be dated no more than 90 days prior to the date of submission.***
